




A Note from the Administrator

This annual report serves the following purposes:

- To provide information about ESU 7 activities to member schools, and

• To provide data by which decision can be made.

Educational Service Units (ESUs) were established in 1965 as a solution to the inequities of educational access and opportunities for not only rural school districts, but also for our more urban districts. ESUs provide for economy, efficiency and cost-effectiveness to our member districts in cooperative delivery of supplemental educational services. ESUs have evolved to become necessary educational partners to school districts of all sizes.

The Educational Service Unit 7 was established and fully operational in 1968. The ESU 7 service area covers nearly 3500 square miles, includes 19 member public school districts, 12,754 students, 1110 teachers, 83 school district administrators, and 94 ESU 7 employees. Our services are determined annually through a data-driven process which directly addresses the needs of the school districts. Our mission is to provide leadership and services supporting the improvement of learning and teaching. We are committed to this focus and work closely with our districts to ensure they have the supports they need.







Production/Art Media


